In 2023, we made substantial headway on our goals, ensuring:

The system centers on both accountability and continuous improvement so that students are prepared and families have choices.

Members supported efforts that will help modernize and optimize the impact of the state's accountability system, explore ways to improve school transportation, and equalize charter school funding.

All students who graduate from high school are prepared for college and career success.

Members helped secure long-term funding for high school students who graduate with an industry-recognized credential, support for improving math education, and an additional \$1,000 in funding per student. Each of these policies also includes provisions to support more equitable access.

Expanding the Career Development Incentive Program

The Career Development Success Program, or Career Development Incentive Program (CDIP), provides financial incentives to school districts and charter schools to offer industry-recognized certificate programs, internships, pre-apprenticeship programs, and AP Computer Science courses—all of which are aligned with in-demand industries.

Since 2016, the state has invested \$22 million to support 32,000 students from 61 districts.

This year, the program received bi-partisan support to invest in its success and significantly increase funding to

The program funds districts for outcomes and provides additional incentives for districts to ensure equitable access to the program. Unlike prior funding, which was sporadic, this new authorization provides long-term stability and consistent funding, helping districts plan and expand. "The CDIP funding increase is a huge win for districts like ours we offer our students pathways directly into the workforce or living-wage jobs while they seek higher education. Without that funding, we couldn't create the authentic experiences necessary for certification. With increased funding, we look forward to expanding our programs and technology to meet our local economy demands."

"We are leading efforts to expand CDIP because the program has allowed us to create a unique public-private partnership helping address the construction industry's talent shortages. Through our partnership with the HBA, we contribute private money to allow 48 high schools to offer the Home Builder Institute's curriculum. Our high school partners use CDIP reimbursements to fund instructors. equipment, and lab space. The bottom-line result is that more than 500 graduates last year were part of our program, and 20% of them went on to work directly in industry in jobs that make a living wage and a great career."
